Flynn is also a current board trustee for the Women's Foundation of Southern Arizona.

For nearly a decade, Mark Montoya has led CFSA's operations. He also provides staff leadership to the Santa Cruz Community Foundation, CFSA's geographic affiliate, and management oversight of the Community Foundation Campus. Montoya has been recognized as a leader in the community foundation field and currently serves on the Community Foundations National Standards Board.

The Community Foundation for Southern Arizona is proud to announce the completion of a large-scale mural by local artist Ignacio Garcia at the Community Foundation Campus.

The completion of this mural fulfills the vision that Clint Mabie, CFSA's former President & CEO, had for the Community Foundation Campus when the building was first acquired back in 2017. As a unique nonprofit coworking and event space, the Campus was designed to be a central place for Southern Arizona's nonprofit community to come together. Clint's vision included a large-scale mural that would communicate to visitors and tenants that the Campus is a welcoming place that values inclusion and equity for all.

Upon the announcement of Clint's retirement in July 2020, several donors generously contributed the funds necessary to bring his vision of a large-scale mural to life. To reach as many local artists as possible, CFSA partnered with the Arts Foundation for Tucson and Southern Arizona to release a call to local muralists and facilitate the selection process. A mural committee comprised of CFSA staff and trustees, Campus tenants, representatives from CFSA's initiatives, and local community members worked together to select three finalists from over nineteen applicants.

After selecting three finalists and reviewing their presentations, the committee selected Ignacio Garcia to complete the mural at the CF Campus. With a unique understanding of the large-scale concept, Ignacio's design proved to be both captivating from a distance and engaging up close to create a visually welcoming Campus. The design wraps around the elevator tower at the northeast corner of the Campus and reflects CFSA's values and purpose.

As a Tucson street muralist for the past seventeen years, Ignacio is proud to have created some of the most intriguing murals throughout Arizona. The opportunity to show the public his beliefs through art further drives Ignacio's passion and led to his interest in the CF Campus mural. He shared, "I wanted a mural for the CF Campus because the direction they are headed in is an expansion of public art that Tucson needs."



Thanks to our generous donors and Ignacio's vision, CFSA is proud to present a mural that not only honors Clint's significant contributions to the Foundation over the last decade, but also highlights the diverse and vibrant communities we serve.



Unprecedented Grantmaking in FY2021

From CORE Grants to COVID-19 Response Grants to our annual Initiative Grant Rounds. CFSA and its donors have distributed more grants in fiscal year 2021 than ever before.

CORE Grants 2021

This year, CFSA awarded \$854,000 in CORE Grants to 42 nonprofits in Southern Arizona - an 18 percent increase in the total amount funded compared to 2020.

CFSA launched the CORE Grants program in 2017 to provide high-performing nonprofits with the flexible working capital they need to maximize their impact and improve the quality of life in Southern Arizona.

With over \$2.3 million in CORE Grants distributed since 2017, CFSA and our generous collaborators remain dedicated to supporting local nonprofits and promoting equity within Southern Arizona with general operating support. Areas funded in 2021 include human services; arts and culture; environment and animals; legal services education; health; youth and elderly services; immigrant services; and support for Native and Indigenous individuals and communities.

CFSA's 2021 CORE Grants were made possible with support from CFSA's Unrestricted Fund and Field of Interest Funds, as well as our Donor Advised Fundholders CORE Collaborators, and the Connie Hillman Family Foundation.

Barbara McClure, Executive Director of Impact of Southern Arizona, shared, "It takes an innovative organization to back the concept of investing in infrastructure and preparation for sustainable capacity building. Thank you for all you do for the community and your amazing support of nonprofits. Because of you, we will all continue to grow strong and provide services for many years to come."

African American Legacy Fund

The African American Legacy Fund (AALF), an initiative of the Community Foundation for Southern Arizona, awarded \$50,000 to eight local organizations in their 2021 grant round to address the educational and economic disparities faced by African Americans living in Southern Arizona.

Founded in 2013 by esteemed educator, philanthropist, and civic leader Dr. Anna Jolivet, Ph.D., AALF brings together people, resources, and goodwill to make sure all our children, youth, and families have the opportunities and resources to prosper. Since AALF's first year of grantmaking, the initiative has granted \$185,661 to organizations serving African American youth communities in Southern Arizona.

LGBTQ+ Alliance Fund

The Lesbian, Gay, Bisexual, Transgender & Queer (LGBTQ+) Alliance Fund, an initiative of the Community Foundation for Southern Arizona, awarded \$82,500 to fourteen regional nonprofits in 2021 - surpassing \$1 million in total funding to support innovative programs that benefit the LGBTQ+ community in Southern Arizona.

The Alliance Fund was created in 1999 by the Community Foundation for Southern Arizona with support from donors, community members, and the National Lesbian and Gay Community Funding Partnership. To date, the Fund has awarded 208 grants, totaling \$1,025,897, to over 65 local organizations.

Mark Montoya, Interim President and CEO of the Community Foundation, shared, "This significant milestone was made possible by our dedicated Alliance Fund donors. We are extremely grateful for their generous investments over the last 22 years to increase available funding for lesbian, gay, bisexual, and transgender programs and services."

Using Your IRA to Meet Your Philanthropic Goals

As one of our CFSA donors has said, "Wealth doesn't mean anything if you don't put it to work." With that in mind, there are many opportunities to support your favorite nonprofits through your retirement accounts.

If you are 70½ years and have a traditional IRA, SIMPLE IRA, SEP IRA, or a retirement plan, you can make a Qualified Charitable Distribution (QCD) directly to a charitable organization and avoid any tax implications. Beginning in the year you turn 72, you can also use your gift to satisfy all or part of your required minimum distribution (RMD).

Although Donor Advised Funds continue to be a popular method for current gifting to charitable organizations, this fund type cannot accept assets from a retirement account. At the Community Foundation for Southern Arizona, we can help you establish a fund that meets your charitable goals and can accept IRA gifts. **Field of Interest Fund:** With a Field of Interest Fund, you choose a particular issue such as art, education, or animal welfare to support, and CFSA will annually award grants to highly effective nonprofits organizations in your selected field. Grants are made to carefully vetted nonprofits in Southern Arizona.

Designated Fund: A Designated Fund allows you to distribute grants annually to your favorite organizations.

The minimum for starting a Field of Interest Fund or a Designated Fund is \$10,000 for a non-endowed fund and \$25,000 for an endowed fund.

If you wish to contribute from your retirement account, but do not want to create a permanent fund at this time, CFSA has several programs that can accept your IRA gift, including our CORE Grants program and annual Civic Leadership Campaign. As part of your estate planning, you may also wish to consider naming CFSA as a beneficiary.
